Opportunities for companies in Italy



The Arabic term with which the city of Dubai was called in ancient times is Al Wasl "connection", reflecting the strategic importance of its geographical position, as a connection point between populations from Europe, Asia, and Africa. Dubai is in fact at the center of the world, geographically and culturally.

The UAE they are located within a few hours of flight from the main international destinations, in the center of an area with 2/3 of the world population, in a time range ranging from 4 to 8 hours of flight. Every major city in the world can be reached from Dubai with a direct flight. Italy is connected to Dubai with direct flights from Rome, Milan, Venice, Bologna, Naples and Catania.

The UAE has now become a global HUB for business, for tourism and, increasingly, for sharing knowledge in every sector. It is home to more than 200 nationalities who work together, exchange ideas and build partnerships to solidify the country's position as a contemporary hub of innovation.
